3. VISITORS, PRESENTATIONS AND PETITIONS

a. Councillor Davis acknowledged former Mayor Woodrow French for his work on the Passenger Bill of Rights. She read the following statement:

Today we have invited into our Chamber a former Mayor of the Town of Conception Bay South, Mr. Woodrow French. Welcome back to the Chamber Mr. French.

This acknowledgement started around 2006 when Woodrow was the Mayor of Conception Bay South. From the online research that I have done, I understand that Woodrow had received a call from a lady one morning telling him about her daughter's flight that was terminated in Halifax instead of St. John's. She was basically left on her own.

Even though such a matter is beyond the scope of responsibility for municipal council, it became apparent that Mayor French was not going to stand idly by.

Around this time Mayor French had recently joined the Board of Directors for the Federation of Canadian Municipalities. Here he started to advocate for better service from the airlines and for consumer protection.

Since then, like most of us, he has experienced or heard of many similar stories. Stories of oversold flights, cancelled flights, lack of compensation for cancelled travel plans, etc..

Woodrow French became an advocate for change. He was a regular caller on radio shows and did many interviews. He worked tirelessly for the air travellers of this Town, Province and Country. He was relentless. He was determined. It paid off for all of us.

Earlier this year the Canadian Parliament passed the "Passenger Bill of Rights'. This bill was to be implemented in two phases. July 15th of this year saw the first phase and December of this year will see the second phase.

Woodrow has been quoted as saying "this Bill is not perfect, but it's a good start".

Today our present Mayor and Council want to acknowledge the hard work and dedication of Woodrow French on making this happen. Because of his lobbying and persistence, air travellers should have a better experience.

Thank you Woodrow French.

Mr. Woodrow French thanked Council members for the acknowledgment and spoke on his efforts for the Passenger Bill of Rights.
